Coronavirus/COVID-19 Waiver for use of Township Owned Park, Park Properties, Recreation Areas and Sport Facility Areas 2020 Fall Sports Season

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact, contact with contaminated surfaces, objects and through the air. People reportedly can be infected and show no symptoms and therefore unknowingly spread the virus. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. COVID-19 can cause serious and potentially life threatening illness and even death.

The Township of Exeter cannot prevent you [or your child(ren)] from becoming exposed to, contracting, or spreading COVID-19 while utilizing the Exeter Township owned Park, Park Properties, Recreation Areas, and Sport Facility Areas. It is not possible to prevent against the presence of the disease, only to mitigate the risk of transmission of the COVID-19 virus. Therefore, if you choose to enter the Exeter Township owned Parks, Park Properties, Recreation Areas, and Sport Facility Areas you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself and/or my children in order to utilize the Exeter Township owned Park, Park Properties, Recreation Areas and Sport Facility Areas for the entirety of the 2020 Fall Season. These services are of such value to me [and/or to my children,] that I accept the risk of being exposed to, contracting, and/or spreading COVID-19.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against the Township of Exeter, and its elected officials, managers, agents, employees, or other representatives in connection with exposure, illness, infection, and/or spread of COVID-19 directly or indirectly related to utilizing the Exeter Township owned Parks, Park Properties, Recreation Areas and Sport Facility Areas. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and malfeasance, and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the State of Pennsylvania will apply to this waiver.
